Information about a Master Series Competition (\$275.00)

A Master Series Contest has four main categories - Chicken, Pork Ribs, Pork, and Brisket. The cooking source at a Master Series shall be of wood, wood pellets or charcoal. KCBS Rules and regulations apply. Master Series are eligible for American Royal and Jack Daniels World Championship, upon meeting qualifying criteria. In addition, all teams who participate in a Master Series earn points towards KCBS Team of the Year awards presented at KCBS's annual banquet.

Information Backyard Contest Sanction (\$125.00)

The backyard contest is comprised of non-professional teams that are required to cook pork ribs to win a prize valued at \$500.00. The cooking source at a Stand Alone Backyard Contest shall be of wood, wood pellets or charcoal. KCBS Backyard Rules and regulations apply.
